## Below is a breakdown of the responsibles and deliverables:

- 1. Conduct research on national and multilateral models to build Al innovation ecosystems and economic competitiveness focusing on best practices, lessons learned, and how they can be applied to the African context.
- 2. Analyze existing policy frameworks and regulatory incentives that can boost domestic Al capabilities to inform the recommendations in the Africa Declaration on Al.
- 3. Engage industry leaders and potential funding partners to gather input on the barriers to investment, adoption, and scale in relation to building Africa's capabilities.
- 4. Research existing public-private-philanthropic fund structures focused on investing in Al capabilities, and extract lessons learned and adaptable approaches to inform the design of the Africa Al Fund.
- 5. Work with a consortium of partners in the drafting and stakeholder consultation process for the Africa Declaration on Artificial Intelligence, with particular emphasis on providing datainformed quantitative and qualitative commitments and metrics.

## **Deliverables**

- 1. **Strategic Plan:** Detailed 3-year strategic plan for the implementation of the Africa Al Council's objectives, including timelines, key performance indicators (KPIs), and stakeholder responsibilities. [Interim Report: March 31, 2025; Final Report: April 30, 2025]
- 2. Africa Declaration on Artificial Intelligence: The Africa Declaration on Artificial Intelligence will be a leaders statement on key priorities and committents for Africa's Al Agenda and mandate the establishment of the Africa Al Council. [March 31, 2025]

- 3. Africa Al Fund Structure: The Africa Al Fund will be a blended investment instrument to fund the commitments cited in the Africa Declaration on Artificial Intelligence. It will be a blended investment vehicle, supported by governments, private capital, and philanthropies. [Interim Report: March 31, 2025; Final Report: April 30, 2025]
- 4. Training Materials and Handover Session: A slide deck that can be used to train Smart Africa staff on the strategic plan and fund structure. One training session conducted to handover materials to staff. [April 30, 2025]

- Deep understanding of the artificial intelligence ecosystem, governance approaches, innovation levers, investment vehicles, geostrategic landscape, and socioeconomic implications
- Exceptional stakeholder engagement and relationship management skills, with experience working with high-level officials in government and multilateral institutions in Africa

- Meticulous organizational and project management capabilities
